

**DIRECTCASH INCOME FUND  
REQUEST FOR FINANCIAL INFORMATION RETURN FORM (2009)**

Distribution of (1) year-end and (2) interim (i.e. 1st, 2nd and 3rd quarter results) financial information requires the commitment of significant resources by issuers. All of the Fund's public Unitholders are unregistered Unitholders (i.e. their names do not show up in the Fund's Trust Unit registers). Typically non-registered Unitholders have decided to allow their stock brokers or other custodian to hold their Trust Units for them. However, pursuant to applicable securities commission rules currently in force, if you are a non-registered Unitholder, you are still entitled to elect to receive financial statements issued by the Fund. If you are a registered or non-registered Unitholder and wish to receive financial statements (including accompanying management, discussion and analysis), please complete, sign and return the lower portion of this page. Your name will be placed on the Supplemental Mailing List maintained by DirectCash (or on DirectCash's behalf).

The securities commissions' current rules contemplate that your election will be renewed each year in order to enable DirectCash to make sure the Fund is only mailing financial statements to Unitholders who continue to wish to receive financial information<sup>(a)</sup>. Accordingly, under current rules, as long as you remain a registered or non-registered Unitholder, you will receive a new election form (similar to this form) each year which you will have to complete, sign and return in order to continue receiving financial statements. **Unitholders who do not complete and return this form will not receive annual or interim financial statements (or accompanying management discussion and analysis).**

- (a) If a non-registered Unitholder has instructed the Unitholder's broker/custodian to not forward Annual Meeting materials distributed by the Fund (and has not allowed the broker/custodian to provide the Unitholder's name to the Fund so that the Fund can carry out a direct mailing) then the non-registered Unitholder will not receive this election form (which is distributed as part of an annual package associated with the Annual Meeting).
- (b) Non-registered Unitholders (as part of their paperwork with the broker/custodian through which the Trust Units are held) will have instructed the broker/custodian as to what kinds of materials the Unitholder wishes to have forwarded. Even if the broker/custodian has been requested to forward financial statements and MD&A, such materials will not be forwarded if this form is not completed and returned to the Fund on an annual basis (i.e. failure to return this form will override the general instructions provided to the broker/custodian).
